IBG Underwriting Managers Pty, 36515, is authorized by the Financial Sector Conducts Authority or FSCA and appoints representatives to render the financial services for or on behalf of the FSP. IBG Underwriting Managers Ptd Ltd has appointed, Mr Ivan Bernard Down as the key individual, to manage and oversee the activities of the FSP and its representatives.

IBG Underwriting Managers is a Category I FSP, its key individuals and representatives that are authorised, approved or appointed only to render financial services, manage or oversee financial services in respect of financial products and to perform the execution of sales for a Tier 1 financial product.

• Reporting Requirements:

IBG submits their financial statements annually, usually within four months of their financial year-end to the FSCA

• Early Warning Indicators:

IBG would notify the relevant authorities in the event their assets exceed liabilities by less than 10% or when current assets are less than 10% of current liabilities.

• Liquid Asset Requirements:

IBG holds liquid assets equal to 6 weeks of annual expenditure at any one time.

Accounting Records:

IBG Submits monthly up-to-date accounting records.
